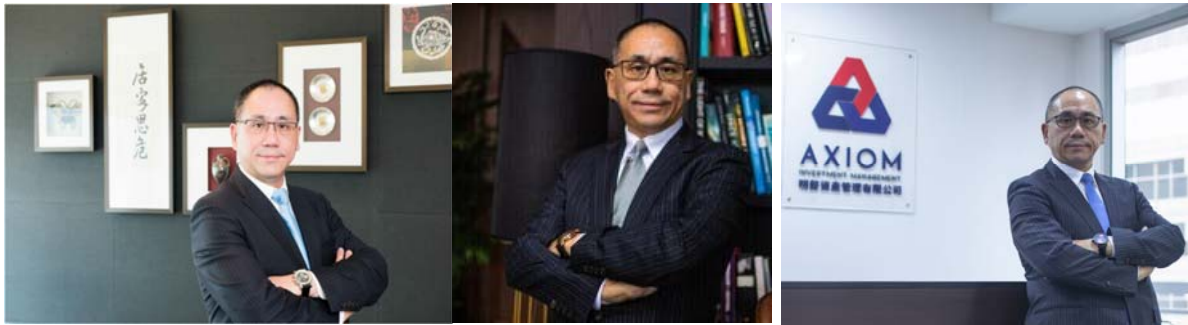


Biography of Mr. Alvin W.K. Ma

Prior to Axiom, Alvin was Senior Vice President & Head of Private Banking, of East West Bank in HK responsible for HK, Macau & PRC wealth management business development & marketing.

Prior to East West, Mr. Ma was Head of Private Banking, previously as Head of Emerging Wealth Private Banking {Executive Officer (EO) of Type 1, 4 & 9 License under the HK Monetary Authority (HKMA)}, EFG Bank in Hong Kong responsible for HK, Macau & PRC wealth management business development & marketing.

Prior to EFG, His last position was General Manager and Head of Private Banking (EO of both Type 1 & 4 License under the HKMA), China CITIC Bank International Limited (CNCBI) responsible for HK, Macau & PRC wealth management business development & marketing. Mr. Ma started up and built from scratch; supervised, managed and coached a group of Private Banking professionals inclusive of frontline and middle and back office members.

Capital Markets Group. Mr. Ma had also worked in Deloitte Haskins & Sells and was Syndicated Loan Officer and Dealer at BA Asia Ltd. Capital Markets Group.
